

Virtual Income Tax Clinics for Low-Income Newcomers & Families

Here comes the income tax season again! In order to help newcomers and low income families file their 2020 income tax returns, Centre for Immigrant and Community Services (CICS), with the collaboration of CPA Ontario, will host free virtual Income Tax Clinics in March & April 2021.

Eligibility criteria for those interested in this free service:

- Have a valid SIN or ITN (Individual Tax Number)
- Annual income not exceeding:
 - Individual/Single: \$40,000;
 - Couple/single parent: \$50,000;
 - add \$2,500 for each additional dependent
- Investment income (Interest and dividends) less than \$1,000 per family
- No self-employment income; no income from rental/business/overseas assets/overseas sources other than pension
- Service not offered to deceased individuals, or people who have declared bankruptcy, or who have capital gains or losses

- 家庭投资收入 (利息, 股息) 收入少于一千元
- 没有自雇、租金、商务收入, 及海外资产/收入(海外退休金除外)
- 服务对象不包括已去世人士、已申请破产人士、和有资本收益或损失人士
