## COVID-19 AUDIENCE SAFETY MEASURES

We are delighted to welcome you back to the P.C. Ho Theatre! The safety of our staff, artists and audience is our priority. We have put in place a number of measures in accordance with the Province of Ontario's reopening plan, and we thank you in advance for your cooperation.



### VACCINATION

Proof of Vaccination – All patrons 12 years of age or older, upon entry to the facility, must provide the following documentation:

- Government issued ID (i.e. driver's license, health card or passport) that matches the proof of full vaccination documentation.
- Receipt of full COVID-19 vaccination issued by the public health authority that administered the vaccine, meaning the full series of a World Health Organization (WHO) approved COVID-19 vaccine or combination of accepted vaccines, received at least 14 days prior to the performance date. Documentation, which can be displayed on a mobile device or printed. For patrons who received their vaccinations in Ontario, documents can be accessed at [covid19.ontariohealth.ca](https://covid19.ontariohealth.ca). Patrons who cannot be vaccinated for medical reasons must provide written proof of a medical reason, provided by either a physician or nurse practitioner, along with a negative COVID-19 rapid antigen or PCR test from a healthcare provider taken within 48 hours of the performance start time. Self-administered at-home tests will not be accepted.

Children under the age of 12 must provide a negative COVID-19 rapid antigen or PCR test from a healthcare provider taken within 48 hours of the performance start time

**Patrons unable to provide this documentation will not be admitted.**



### MASKS

All visitors and staff will be required to wear a mask that fully covers the nose, mouth and chin at all times during their visit to the theatre. Masks should fit snugly against the face without gaps; cloth masks should have at least two layers of fabric. Neck gaiters and bandanas are not permitted.



### SANITIZATION STATIONS

We ask that you use the hand sanitizer provided as you enter the theatre. Sanitizer can also be found at designated points throughout the venue.



### CLEANING

Enhanced cleaning measures have been put into place before, during and after each performance. Common contact surfaces and washrooms are regularly sanitised by our on-site cleaning team.



### PHYSICAL DISTANCING

On both the main floor and the balcony of the theatre, measures have been put into place to keep our patrons at least 2 metres apart from other patrons throughout the show.
